Beatrice congratulated the Taranaki Club for once again winning the annual Cowbell Competition final against Hamilton earlier in the day.

**President's Report:** (Beatrice Leuenberger reported) Having celebrated the end of the Millennium in Wellington in 1999, we are meeting now in Auckland to take the Society, now in its 66th year and still strong and active, into the new century.

Our membership has again increased slightly, with a net increase of 40 over the past five years. Many are new immigrants from Switzerland - and contact is made through the Embassy, the internet website, word of mouth and a pro-active approach. Once again, thanks go especially to our Editor, Rinaldo Rust, for consistently producing the *Helvetia* magazine to such a high standard each month. Thank you also to the team of 'packers' who then prepare the *Helvetia* for posting, as well as all other committee members for helping in the smooth running of the Society. The new system of collecting Sub payments from Clubs at regular intervals is working well - thanks to all Club treasurers for prompt payments. Address lists are also being checked by Clubs annually, with only minor changes required. Very little mail is being returned.

As reported in the June 2000 *Helvetia*, the proposed Business Directory would not go ahead. Although a reasonable number of responses was received, there were not enough to warrant the work. The information received will be safely filed and kept for possible future reference.

In line with tradition, our new Ambassador was recently asked to become our Honorary Patron for the duration of her posting in New Zealand, a role Mrs Matteucci has accepted. The report was moved for adoption.

**Introduction of Ambassador:** After being without an Ambassador for some time, the unexpected recent announcement that one had finally been appointed to New Zealand came as a surprise to many! The President introduced the Ambassador, Mrs Matteucci, with a brief description of her diplomatic postings spanning nearly three decades - this one being the first outside of Europe. Beatrice welcomed Mrs Matteucci to New Zealand, wishing her a happy and successful time here, and also thanked her for becoming the Society's Honorary Patron.

**Address by Patron of the Swiss Society:** Mrs Matteucci thanked Beatrice for the introduction, and passed on greeting from her 'boss' Josef Deiss (Auslandminister). She explained that New Zealand was without an Ambassador for four years: following the collapse of the Berlin Wall, all available diplomatic staff were required for the newly 'opened' countries of Eastern Europe. But it is still important for New Zealand to have an Ambassador. Currently, there are approx. 5000 registered Swiss citizens. It was hard for Switzerland to keep the WTO (World Trade Organisation) in Geneva, but with Mike Moore as current WTO Chairman, there is even more reason to have an Ambassador in New Zealand, Samoa and Fiji. Mrs Matteucci is the 8th woman Ambassador in New Zealand.

**Financial Report:** (Beatrice Leuenberger reported) Copies of the financial report were circulated for everyone to read. Excess Income of \$2049 was only slightly lower than previous year. The Committee and Editing Team are always aware of costs, and every effort is made to maintain and increase membership numbers and have adequate advertisers. Accumulated funds as at 31 March 2000 were \$28,559.

**Riflemaster's Report:** (Peter Rust to attend and reported in writing) The annual competitions have again been well supported, with people still keen to win a medal. A good number of younger members participated in the now popular junior categories. Swiss farm houses will continue as a theme for the medals. The Riflemaster's Financial Report once again shows a loss, this year about \$450, however at this stage there are still sufficient funds in the account to cover costs without increasing competition fees. Exchange rates, which are quite low at the moment play a big role in the annual cost of medals imported from Switzerland. Peter thanked everyone who had helped him throughout the year.

The committee sees no valid reason to adjust subscriptions for the coming year, and moves that the fee once again be set at the



current cost of \$25 per household.

**General Business:**

1. Club Reports: Club Presidents - Walter Seifert, Taranaki; Herbert Staheli, Hamilton; Roland Schütz, Wellington; and Ernst Gfeller, Auckland - each gave brief reports on the past year's activities in their Clubs.

2. Funds Received: Beatrice informed the meeting that a letter, dated 21 May 2000, together with a cheque of \$1686.45 had been received from Past Society President, André Schleicher, of Wellington. These funds are the surplus from the 'roadshow' organised by the Swiss Embassy in 1991, to celebrate 700 years Switzerland. Beatrice suggested that these funds be deposited into a separate savings account at this stage, and that it be mentioned in the *Helvetia*, so that Clubs and members may have some thoughts on what it could be used for. This was briefly discussed. *Motion: that the funds be deposited into a savings account.* Carried

3. Changes of Address: Members are requested to please advise the secretary of any changes of address as soon as possible so that *Helvetia* magazines can be correctly addressed and are not returned.

4. Medal Competitions: It was asked whether the cost for medal competitions would increase - this was also discussed at the previous AGM and it was found that a price increase was not yet justified, as there were still sufficient funds in the Riflemaster's accounts, which are totally separate to the Society's accounts.

**Venue for next Meeting:** Hamilton Club President, Herbert Staheli, invited all members of the Swiss Society to meet in Hamilton at Queen's Birthday Weekend 2001, where the Hamilton Swiss Club would be pleased to host the next AGM.

**Meeting Closure:** On behalf of the Society, Beatrice accepted the invitation of the Hamilton Swiss Club to host the next meeting, and sincerely thanked and congratulated the Auckland Club committee and members for a very well organised and successful AGM weekend.

Finally, Beatrice thanked all members present for their attendance and participation, and wished everyone an enjoyable evening function and a safe journey home.

The 2000 AGM was declared closed at 3.20 pm.
