## SWISS MERCANTILE SOCIETY.

The latest news from Headquarters of the S.K.V. in Switzerland give interesting facts of the alterations in the Central Committee necessitated through the resignation, after nine years successful leadership, of Mr. A. Gubser as Central President.

The new Central President, Mr. Carl Strickler of Zürich, the youngest S.K.V. member to hold this exalted position, has with him as Vice-Presidents Messrs. Carl Weigl and E. Flueckiger and the Central Committee now has two lady members. The Central Secretariat remains as before in the hands of the ever energetic Nat. Councillor Mr. Schmid-Ruedin, supported by Messrs Fritschi, Galliker, Losey, Baumgartner and Meier, all well known to our London Members.

The year 1941, so memorable as 650 years of Switzerland is equally a year of importance to the S.K.V. Exactly 80 years ago, in 1861, the S.K.V. was born in Zürich and from modest beginning has now grown to an organisation with a membership (including young associates) of nearly 50,000.

Just like our forefathers of the Swiss Federation, so the pioneers of the S.K.V. started in a small way, proceeding always stéadfast and true to their ideal not only to safeguard and improve the status of the commercial community but also to work in harmony with the existing constitution and authorities for the welfare of the community as a whole.

The S.K.V. is justly proud of the successes attained, the institutions it has established and which it maintains; the S.K.V. is to-day acknowledged a usefully appreciated and honoured part of our national, economic and cultural community.

The London Section justly claims some share in these honours for it also had successes since the section was founded some 53 years ago. Although the war has curtailed its activities, has closed its day school and evening classes, it is maintaining close relations with its friends at home. In London the S.M.S. is carrying on in the spirit of the founders and only awaits the day when peace will reign again, international commerce be restored and a flow of young Swiss compatriots will again be able to come to this hospitable country to learn English and to enrich their commercial experience.

The help of our Swiss Authorities and our Central Society is assured and the London Section will not be lacking in effort and enthusiasm. With this in mind I appeal to all London Members, our Contributing Members and friends to support the Committee in their endeavour to keep faithful to the Society and true to our ideals.

Opportunity is given to our members and their guests to meet old and new friends at our next meeting. An interesting talk by Dr. Bircher of the Swiss Legation, Special Division, is arranged for Saturday, September 13th, at 2 p.m. at Swiss House. All Members and friends of the S.M.S. are welcome.
