Hakas and Maori songs given by two Maoris of no mean ability, intermingled with the dancing.

An oil painting by Mr. Camenzind was also raffled during the evening, the lucky winner being Mr. A. Schumacher of Te Aroha.

The proceeds of this dance, amounting to £11, were thankfully acknowledged by the Red Cross Society.

The Consulate in Wellington has received the following letter from Australia :-

"Dear Sir,

On my return trip from Switzerland to Australia, last year, I had the pleasure of meeting a Mr. & Mrs. Steiner and child. These people told me they would like to settle on a farm.

I would be willing to lease my farm on a 50-50 basis. There are 228 acres land, 120 cattle and a number of pigs. The land is 3300 feet above sea level, plenty of fresh water all year around, 4-roomed house, garden, garage, etc. Much of my time is spent in Sydney, and I would let the farm on management; money is not necessary, and I would be willing to sell out later.

Should the Steiner family already be settled in New Zealand, perhaps you would know some other Swiss interested in the proposition. I thank you in anticipation,
