GENEVA BUS DRIVERS TOO OFTEN SICK

Apparently the Geneva bus drivers are not as healthy as their colleagues in other Cantons. In 1991 the Management of the Geneva public transport company calculated that 33000 working days were lost to sickness, more then 6% of the total working days paid, which cost the company some 8.2 million SFR. On the average, each Geneva bus driver reported sick on almost 24 days a year. This is clearly a much higher average compared with Zurich (15 days), Lausanne (16 days) and Basle (17 days). convinced that many drivers take "sickies" and from now on will only accept certificates from "approved" doctors to stop the practice of obtaining false certificates from very lenient and easy going general practitioners.
