### Swiss Abroad Congress 2000

The 78th Congress, the first of the new Millennium will take place in Zug, from the 17th to the 20th August.

The theme will be "Education and knowledge in the Future", supply, development and strength of Switzerland as a place of education. More information will be published in the next 'Swiss Revue'.

## **Congress Minutes 1999**

The minutes of last year's congress held in Lausanne are obtainable from me, as is any other information regarding the Swiss Abroad Organisation's activities or those of the Secretariat.

### Recent Parliamentary Elections in Switzerland

The 24th Oct. 1999 marked only the second time that the Swiss Abroad could take part in electing a new Federal Parliament. - The results showed the "Fifth Switzerland" is more interested in Referenda than elections. Two reasons point to the rather 'feeble' participation.

1) the complexity of the election procedure, and (2) the lack of information on Candidates. I would add a third reason: inadequate time to absorb the information received! (Heinz). - Further to that, under the present election system, Swiss Abroad Candidates have a less than minimal chance of electoral suc-The questions we must ask ourselves is: what can we Swiss Abroad do to improve the situation? National Council member - Rosmarie Zapfl, on the 5. October 1999, presented the Federal Council with the motion: To take steps to optimise the electoral system and participation of the Swiss Abroad on the election lists. Of the 570,000 plus people registered abroad, 70,000 exercise their political rights. With the expanding participation in Swiss politics, it's important that the right to participate is made as optimal as possible. In view of the rapid advance of information technologies, it's possible to buy or visit almost anything on the Web - so why not make it possible to vote via the Inter-
