Message from the Embassy

Swiss Passport 03 - US visa

In accordance with current US laws, the Swiss passport 03 with date of issue prior to 26 October 2006, allows you to travel to the USA without a visa until the passport expires. The Embassy of Switzerland in Wellington recommends that you order your passport 03 as soon as possible. In order to get the passport issued before 26 October 2006, you should apply for the passport already now but at the latest at the end of August 2006. The price is NZ\$ 155.- including postage (Sfr. 120.-.)

Swiss biometric passport (passport 06)

The Federal Council has decided that new biometric passports will be available from September 2006.

The new biometric passports can be obtained in 16 registration centres. The

registration centres are located across Switzerland in the cantons of Aargau, Berne, Basle City, Graubünden, St. Gallen, Ticino, Zürich and Vaud and cover all the country's language regions.

The following eight Swiss representations are designated centres for recording biometric data for Swiss citizens abroad: Paris, Frankfurt, London, New York, Toronto, Sao Paulo, Hong Kong and Sydney. More information will follow.

The biometric data required for the passport 06 can be registered at any of these centres irrespective of the applicant's place of residence. Swiss Abroad can therefore register their biometric data also at cantonal registration centres while visiting Switzerland.

The price is NZ\$ 300.- (Sfr. 250.-.)
