
What are the names of your local cinemas?.. yes really!!!!

I wish you all well for the next few months and hope that unlike me you survive the winter months without being laid low with the sniffles.

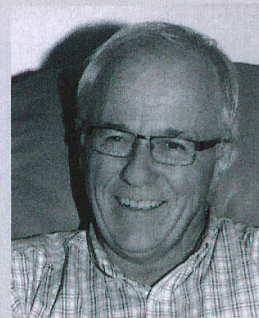

ONE: your committee has been working at overhauling the Society Constitution and Sports Rules but we failed to realise just how much work this created for us and the clubs. In the end there was no, or late, feedback from the clubs and we made the decision to postpone adoption of any amendments to the Constitution and Sports Rules. We did pass a resolution to attend to this over the coming months with the intention of having an agreed revised version ready for presentation at the next AGM.
