He is the author of *Shakespeare as Literary Dramatist* (Cambridge University Press, 2003) and Beyond "The Spanish Tragedy": A Study of the Works of Thomas Kyd (Manchester University Press, 2001), and the editor of Textual Performances: The Modern Reproduction of Shakespeare's Drama (Cambridge University Press, 2004).

She is Research Associate in the Centre for Gender and Women's Studies, Trinity College, from which she holds an M.Phil. She has published several articles on the relations between gender and whiteness in literature.
