MEETING OF THE COUNCIL, September 21st, 1921,

2. A big scheme has been started in Switzerland to put the activity of the Secrétariat pour les Suisses à l'Etranger on a new financial basis. The initiators expect to raise 100,000 francs.
3. It was agreed that the Secretary

should take up relations again with the "Anglo-Swiss Review."

Mr. Duruz, manager of the Swiss Federal Railways Agency, gave an extensive report on the Passport and Visa problem, which threw light on the various aspects of this question. After a lively discussion the following resolution was adopted and eventually forwarded to the S.S.E.:—"The Council of the London Group of the N.S.H. expresses its gratification at the intention of the Federal Authorities to abolish the visa of passports for the subjects of certain countries granting reciprocal treatment to Swiss citizens, and trusts that such an arrangement will shortly be concluded between Switzerland and Great Britain. The Council hopes, however, that no complicated system of Cantonal Control necessitating repeated registration of foreign tourists in Switzerland will be substituted for the present Federal control."

A Propaganda Committee, con-

sisting of five members, and an Entertainment Committee, consisting of three, was elected. The former will consider ways and means to increase the membership; the latter will arrange an informal dinner for October. Two supplementary members were elected to the Entr'Aide

LECTURE ON "SOCIAL REFORMS OF RECENT DATE IN SWITZERLAND-ACHIEVEMENTS AND SCHEMES."
