93 and 88, and J. Haesler with 90. On the 300-metre target Krucker scored 23 points out of a possible 30. Thanks to the sacrifice of some ardent members who spent a few evenings digging and shifting earth and sand, the 300-metre range is again "bulletproof." In order to facilitate control and regulate shooting generally, the range officers have decided that practice on the 300-metre range should take place on Sundays only between 10 a.m. and 1 p.m., and under certain conditions on Wednesdays (by arrangement only). Furthermore, only those members who have arrived at a certain degree of efficiency and are of full military age will be entitled to shoot with the Swiss army rifle and ammunition. The test will be three scores of at least 85 points on the present Michoud target. Those who have already qualified during previous practice are: Burger, Ernest, Holliger, J. Haesler, Krucker, Rohr, Ar. Schmid, Ad. Schmid. Their number should soon be increased, as a good many have already two such scores to their credit.

Last Tuesday Col. Borel, the president of the City Swiss Club, accompanied by Madame and Mademoiselle Borel, handed over the Swiss army rifle kindly presented by the latter club. (His patriotic speech will be fully reported next week.) About forty members of the two clubs were present, and the competition which the City Swiss Club had arranged was very successful and, in view of the fact that practically all those competing had not handled a rifle for 10 to 20 years, the results were most creditable. Mr. Despond, the popular secretary of the C.S.C., was an easy first with 76 points out of a possible 100; the second prize was secured by M. Corbat with 70 points. At about 6.30 those attending were taken over by cars to the Brent Bridge Hotel for the dinner and dance of the C.S.C. and, needless to say, passed a glorious evening, exceptionally fine weather favouring the occasion.

ENFANTS SUISSES A L'ETRANGER.

Monsieur le Rédacteur du S.O.,

La lettre de Monsieur Ag. Krafft publiée dans le dernier numéro du S.O. nous a beaucoup intéressé car la question si les enfants de parents suisses nés en Angleterre peuvent rester Suisses n'est certe pas facile à résoudre.

Quand nos enfants sont nés, nous les avons faits inscrire, avec plaisir et fierté, dans notre commune d'origine en Suisse, croyant que par ce fait ils étaient Suisses. Toujours nous leur avons inculqué l'amour de la Suisse et avant la guerre nous les conduisions passer les vacances en Suisse pour leur apprendre à aimer notre patrie.

En 1918 notre fils atteint l'âge de 18 ans, et l'Angleterre l'a appelé aux armes. Son devoir était naturellement de répondre à cet appel quoique nous aurions pu invoquer l'aide de la Suisse pour obtenir l'obtention de l'armée anglaise, mais l'Angleterre avait alors besoin de tous les soldats et notre fils a fait partie de l'armée britannique pendant deux ans.

A 21 ans il a dû opter pour l'un ou l'autre des deux pays et c'était notre grand désir qu'il opte pour la Suisse. Mais voici ce que la Suisse nous dit: "Votre fils, né en Angleterre est de ce fait Anglais, nous lui donnons la qualité de Suisse en Suisse, en retour il doit ou faire son service militaire en Suisse ou payer la taxe militaire, en dehors de la Suisse il est anglais et nous ne nous intéressons nullement à lui."

Que pouvait faire le jeune homme? Naturellement renoncer à être Suisse et être anglais pur et simple.

Mais supposons qu'il ait opté pour la Suisse et qu'il soit allé habiter la Suisse, il aurait été Suisse en Suisse, mais s'il avait voulu sortir du pays il aurait dû avoir un passport anglais.

Il y a encore un autre aspect à la question que nous devons reconnaître malgré notre patriotisme et notre amour pour la Suisse: il y a bien plus d'avantage pour le jeune homme né en Angleterre et habitant l'Angleterre à être anglais que Suisse. La protection d'une nation aussi puissante que l'Angleterre n'est pas à dédaigner.

Si encore la Suisse se contentait dans ces cas d'une taxe nominale et régulière, disons de 20 à 50 francs par an, on les payerait avec plaisir pour pouvoir être Suisse en Suisse, mais au lieu de cela la taxe est fixée, nous dit on, non seulement sur son revenu mais aussi sur l'héritage prospectif qui pourtant est problématique et sur lequel l'Angleterre met une main déjà bien lourde.

EMIL BUSER. †

We are very sorry to announce the sudden death, at the age of 66, of Mr. E. Buser, of 12, Versailles Road, Annerley, S.E. His health had been failing since last October, but he was able to come to the City up till Friday week (20th June), when he collapsed on his way up.

Mr. Buser was born at Rotenfluh (Basel-land) and came to England in his early youth. He lived first in Manchester, until he founded, about 35 years ago, the firm which bears his name at 44, Gutter Lane, E.C. He was a very hard worker, who never spared himself. He was always open-handed, and no one in real distress appealed to him in vain. Not long before he died he was talking of going for some time to Switzerland, which always held a warm corner of his heart, to try to regain his health there, but, alas! it was too late; he felt already too tired to carry out his purpose. What must have been a great satisfaction to him, and certainly a consolation to his wife and daughter, is that he was able to see his son, who was just back from India for his holiday after four years' absence. Mr. Buser will be missed by a good many in private as well as in business circles, and will long be remembered for his kindness of heart.

Mr. Buser was a most useful member of the "Commission économique Suisse" in London, and in former years actively interested himself in the work carried on by the Swiss Institute, the Swiss Mercantile Society and the Nouvelle Société Helvétique.

He was buried on Friday, June 27th, at Elmers End Cemetery, Annerley.
