Bei einem Vergleich mit den Zürcher Sätzen ist zu berücksichtigen, dass für das laufende Jahr eine kleine Ermässigung der städtischen Steuern eingetreten ist; die Ansätze für 1923 haben sich also leicht reduziert.

**Die Vermögenssteuer.**

Grosse Unterschiede bestehen auch bei der Belastung der Vermögen; auch hier zeigt sich, dass einzelne Gemeinden die kleineren und niedrigeren Vermögen stark belasten, die grossen Vermögen hingegen schonen. Besonders auffallend ist dies wiederum in der Ostschweiz. Ein Verheirateter ohne Kinder hatte für sein Vermögen, wenn es in Wertpapieren bestand, folgende Steuern zu bezahlen:

**SWISS SPORTS.**

On Thursday, July 3rd, the Committee of the Swiss Sports, together with the delegates from the Swiss Societies in London, met at the Union Helvetia, Gerrard Place, W.1.

The minutes of the last meeting were read and approved, as were also the accounts regarding revenue and expenditure of the Sports Meeting held at Herne Hill on May 31st, 1924. It was noted with great satisfaction that, as in previous years, the appeal for funds towards the expenses of this year's Sports was responded to in a splendid manner. As will be seen from the copy of account printed hereafter, the donations, etc., exceeded the expenses to the extent of £26 19s. 9d. Thereof the meeting voted £25 to be allocated to the Fonds Georges Dimier. The remaining balance of £1 19s. 9d. is being carried forward.

The old Committee was re-elected unanimously with acclamation, and therefore consists of the following gentlemen for the next twelve months:—President, Mr. C. A. Barbezat; Vice-President, Mr. R. de Cintra; Secretary, Mr. C. Kiefer; Treasurer, Mr. H. Senn; Asst. Treasurer, Mr. C. A. Aeschmann; Directors of Sports, Messrs. R. Dupraz and J. Sermier; further, Messrs. E. Bloch, H. Nozières and R. E. Pfister; Auditors, Messrs. A. Rueff and Dr. P. de Wolff.

The business of the evening was dealt with smoothly, and the various discussions were conducted in the same good spirit which animated the meetings of the past and which has become traditional for the Swiss Sports.

After the close of the meeting, the draw took place of the raffle for a Bulle Clock which had kindly been presented by Mr. H. Binguely as a special prize. By a new invention, the clock in question does not require winding up, but will go "tick-tacking" for many years. The Committee decided to organise a raffle for the clock, the value of which was considered to be too high for being given away in the form of a Sports prize. All the subscribers and donors, without exception, of minimum 2/6, were allotted a number for every half-crown contributed, and the winner of the clock is Dr. K. Eckenstein, who had subscribed £1 1s. on the list of the members of the City Swiss Club. It was a pleasant surprise for him,

as he had not known that his donation was going to be included in a raffle of any kind. C. A. A.
