SWISS FINANCE.

The extraordinary increase of the circulation The extraordinary increase of the circulation and the corresponding growth of the gold reserves in Switzerland, which have been an outstanding feature of the monetary situation since the middle of 1931, receive their first full and authentic ex-planation in the annual report of the Swiss National Bank. The banking troubles in Austria and Germany, followed by emergency legislation in Germany and the general undermining of con-fidence, gave rise to a large demand for Swiss bank notes from abroad. Short-term deposits were withdrawn and the money was not converted

bank notes from abroad. Short-term deposits were withdrawn and the money was not converted into foreign currencies, but for the most part kept in the form of notes and hoarded. The National Bank at first adopted the attitude that it was its duty to provide the cur-rency required and so to assist in stemming the crisis, but the demand for notes soon assumed such immense proportions that it finally became necessary to call upon the banks to restrict their payment of Swiss notes to foreigners as far as possible. possible.

SWISS NATIONAL BANK.

Accounts for 1931 show that, after allowing depreciation of Frs.675.336 and writing off losses of Frs.360,000, net profits were Frs.5,703,922. Of this, Frs.500,000 is allocated to reserve fund, increasing reserves to Frs.10,500,000. Dividend of 6 per cent. is being paid, and balance of Frs. 3,703,922 allocated to Federal Treasury for dis-tribution between Treasury and Cantons.

SWISS BANK REPORTS.

(1930 — 7%); St. Gallische Hypothekar-kasse — 4 per cent.; Hypothekarbank Lenzburg — 7 per cent. (1930 — 7%).

RESIGNATION AT THE FEDERAL EMIGRATION

OFFICE. M. J. Möhr, Chief of the Federal Emigration Office in Berne has sent in his resignation — to take effect from the 1st of April — same was accepted by the Federal Council, who expressed their appreciation for long services rendered. M. Möhr occupied this position for 22 years and was altogether 34 years in the service of the Con-federation.

SWISS WATCH-MAKING INDUSTRY.

The report that the "Movado" watch making factory at La Chaux de Fonds had been compelled to close down, published in the Swiss Observer of January 30, is incorrect. We are now informed that the factory is merely working with a some-what reduced staff owing to the crisis in the in-dustry, and is concentrating on the manufacture of the most saleable types of watches.

WIRELESS LICENSES IN SWITZERLAND.

Swiss licence figures have risen by close upon fifty per cent. during 1931, due to the opening of

the high-power station at Sottens and Beromünster. On January 1st, 1931, the figure stood at 103,808; the high power stations were inaugurated during the year, and on December 31st there were 150,021 licence holders

TAX-FREE SWISS COMMUNES.

Some years ago there were in Switzerland a certain number of happy communes, the citizens of which paid no taxes and even received at the end of every year a certain quantity of wood, of butter and cheese, and sometimes a few francs. These communes obtained a considerable revenue from their forests and pastures, and after paying the taxes of the citizens to the Canton and also the communal expenses, the profit remaining was

the communal expenses, the profit remaining was distributed in kind among the citizens. Among these communes were that of Baulmes, in the Jura, and Rossinières, in the Alpes Vaudoises. Since the War conditions have so much changed that, one after the other, these prosperous communes were compelled to give up the yearly distribution of wood, butter, and cheese, and they nearly all set up communal taxes to meet the increasing needs of the community. The last of these tax-free communes was that of Coeuve, near Porrentruy, in the Bernese Jura, which possesses a wide area of forests, Until last year the citizens of Coeuve still enjoyed the an-nual distribution of wood, but the Golden Age is nual distribution of wood, but the Golden Age is now over and it is any meed that the commune has decided to suppress he delivery of free wood and to set up a communal tax as from 1932.

Dr. Fridolin Störi, the well-known Zurich Art dealer, who suddenly disappeared, two weeks ago, leaving a considerable amount of debts be-hind, has been arrested at Vigo (Spain).

RERNE.

M. Moritz von Schiferli who has recently died las left an amount of 240,000f. to be divided amongst the following charitable institutions :— Gotthelfstiftung (zugunsten unheihbarer Kinder); Mädchenerziehungsanstalt Victoria in Wabern and Armenerziehungs-Anstalt Bächtelen in Wabern. Each institution receives 80,000f.

The death is reported from Burgdorf of Oskar Scheitlin-Schürch, Managing-Director of the "Vereinigten Leinenwebereien Worb und Scheitlin A.G." at the age of 37.

BASEL.

Two young men, returning from the carnival, started a dispute at 6 o'clock in the morning on the Barfüsserplatz which ended in a fight, the result of which was that one of the combatants was killed. The agressor, a 21 years old man, has been arrested.

GENEVA.

GENEYA. A Geneva watchmaker has invented an electric watch, the size of an ordinary pocket timepiece, which never needs winding up. All that the possessor need do is to have the tiny accumulator recharged once every year. The electric works take up about one-half of the inside space of the case. The instrument keeps precise time.

M. Marcel Welsch, a musician, disappeared suddenly after the conclusion of a concert. In spite of immediate steps taken by the Police his wherabouts remained a mystery. He has now been found dead with a bullet wound in his head,

in one of the Public Parks. Welsch, it is reported, has lately suffered from neurasthenia, and has ended his life by committing suicide.

AARGAU.

The engineering works Brown Boveri, at Baden, will remain closed on Saturdays, on and after, March the 1st owing to the crisis.

Dr. Riedel, a medical practitioner, who has been recently acquitted at the Assizes in Burgdorf of the murder of his former wife, has received the permission to open a practice in Kaiserstuhl-Fisibach.

ST. GALLEN.

From St. Gallen comes the news of the death of M. Ed. Sturzenegger, Chairman of the "Stickerei A.G." in St. Gallen.

VAUD.

The cantonal budget for the year 1931 closes with a surplus of 359,000f. instead of an anticipated deficit of 1,129,000f.

TICINO.

The Conservative party has nominated M. Riva as candidate for the Parliamentary re-elec-tion. M. Riva, who is a lawyer, has already represented his canton in Parliament.
