of them, especially international ones enjoyed a large turnover and steeply rising prices. Amongst those with the biggest gains were Hispano, Italo-Argentina, Royal Dutch and Nestlé, for which evidently French buyers were largely interested. Under the influence of a somewhat more hopeful New York atmosphere American railways gained back some of their previously lost ground. Swiss trust companies proved to be little attractive and gains as well as losses kept within sensible limits. Also bank shares varied slightly only, while insurance stocks were looked for steadily and improved somewhat. A number of Swiss industrials showed lately stronger features. The most representative ones were Bally, Aluminium, Maschinenfabrik Oerlikon, Fischerstahl, Nestlé and numerous others, while business in foreign industrials was very small and concentrated almost entirely on a few Italian stocks.

A Psychological Film.

It is not often that a popular film dealing with a medical subject can be taken seriously by the profession. An exception is the film, produced in Switzerland and now being shown in London at the Academy Cinema, entitled *Die Ewige Maske* (The Eternal Mask). While open to criticism in certain medical details, it is a serious attempt to present to the layman the arguments for and against the use of psychotherapy in certain cases of emotional crisis. The general atmosphere of hospital life has been well caught, and the film is something of a technical achievement, especially in its portrayal of the subconscious mind. The dream state is symbolized by globes of light filtering across the vision of the patient, thus differentiating quite clearly to the spectator the scenes of reality and those which are occurring in the subconscious only. It is interesting to see how far the screen can be employed in this direction and how much can be conveyed visually by subtle camera work. It opens up a field for further experiment. The directors announce it in the programme as "a striking study in psycho-analysis," but it has nothing to do with psycho-analysis properly so-called.

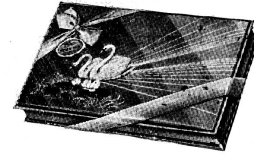
