CITY SWISS CLUB.**Monthly Meeting.**

The Monthly Meeting of the City Swiss Club was held on Wednesday, January 10th, at the Dorchester Hotel, Park Lane, W.1., and was preceded by a dinner, which was attended by 105 members and friends.

The President, Mr. A. Bon, opened the Meeting by welcoming the guest of honour, Sir William Jowitt, P.C., K.C., Minister of National Insurance, expressing to him the appreciation of the members for having kindly consented to address the Meeting. He also extended a hearty welcome to Monsieur Ruegger, the Swiss Minister and the other guests present.

Sir William in his introduction paid a warm tribute to our country for its humanitarian work, saying that Switzerland will, at the conclusion of this war, occupy a high place in the Roll of Honour, a remark which was highly appreciated, coming, as it did, from one of H.M.'s Ministers.

The speaker then gave a concise and most interesting *exposé* in relation to the Government's plans for National Insurance, based on the Beveridge report. It is to be regretted, that certain rulings do not allow me to report fully on this vast and important subject, which will come before parliament in the near future.

Sir William received a hearty ovation on concluding his address, which was followed by a keen discussion in which Messrs. Ritter, Baume, Jobin, Bircher, Boos and Egli took part.

Monsieur Ruegger, the Swiss Minister, expressed his appreciation to the speaker for the masterful way in which he spoke on a subject of world wide interest, acquainting him with some of the steps which the federal and cantonal authorities in Switzerland have undertaken, both in the past and present, in the sphere of National Insurance.

The President associated himself with the words spoken by the Minister, expressing, at the same time his admiration for the present head of H.M.'s Government, and for the great efforts made, especially in the realm of social insurance, in this country.

Before closing the Meeting, Mr. Bon informed the members of the promotion of Dr. Kessler and M. Aubaret to first Secretaries of Legation and M. Hunziker to second Secretary of Legation, extending to them, on behalf of the members, his sincere congratulations.
