Annual General Meeting at Swiss House, 35, Fitzroy Square, W.1, on Sunday, 2nd March, 1947.

A sure and encouraging indication of the strong support the Ladies' Section continues to receive from its members was to be seen in the excellent attendance at the Annual General Meeting.

We are happy to say that our President, Mrs. T. Lunghi-Rezzonico, has made a remarkable recovery from her recent illness, and she had indeed been hoping to attend the meeting, but unfortunately, at the last moment, in view of the severe weather conditions, the doctor advised otherwise. However, with warmer days ahead, the members look forward with pleasure to welcoming back their dearly beloved President.

In her absence, the Chair was taken by the Vice-President, Mrs. A. Berti, who opened the meeting with a word of welcome to all present.

**UN GRAND PRIX POUR AUTOMOBILES ET
MOTOCYCLETTES COMME ON N'EN VIT
ENCORE JAMAIS.**

Les 7 et 8 juin 1947 à Berne.

Le très roulant circuit de la Forêt de Bremgarten, à Berne, a déjà vu se disputer plus d'un Grand Prix; chaque année, avant la guerre, il attirait sur tout son pourtour la foule des amateurs de grand sport, qui venaient applaudir aux prouesses des champions du volant ou du guidon. Cette année, ce sera mieux encore, car les spectateurs assisteront à un meeting d'une importance exceptionnelle: Grand Prix Suisse des automobiles et Grand Prix d'Europe des motocyclettes seront combinés en une seule et même manifestation. Jamais encore, une épreuve de cette envergure ne s'est déroulée sur aucun circuit européen, si bien que les 7 et 8 juin seront de grandes journées sportives.

Les essais sont fixés au jeudi après-midi 5 juin, ainsi qu'au vendredi 6 juin, matin et après-midi. La réception des véhicules engagés aura lieu le matin du samedi 7 juin: pour motocyclettes au poids public de la Place de l'Orphelinat, à Berne; pour les voitures de sport et de course devant les boxes de la route de Morat.

Le circuit sera fermé à la circulation dès midi le samedi 7 juin, car les courses débiteront déjà à 14 heures et se poursuivront jusqu'à 18 heures environ. Le départ de la première course prévue au programme de la journée du dimanche 8 juin sera donné à 9 heures et le meeting se terminera vers 17 heures par les épreuves réservées aux grands maîtres du volant. Le programme détaillé des différentes épreuves, qui aligneront successivement voitures de sport et de course et motocyclettes sera publié incessamment. Il donnera tous renseignements concernant les heures de départ, les distances à couvrir, etc. Qu'on sache cependant déjà qu'un bal de la course est prévu pour le samedi 7 juin au Kursaal et que la distribution des prix, suivie d'un bal, se déroulera le dimanche soir à l'hôtel Bellevue-Palace.
