SWISS MERCANTILE SOCIETY.

There was a record attendance at the Monthly Meeting, held at Swiss House on Wednesday, December 14th. The chief attraction was a film show, to which the Students of the College had also been invited.

Reporting on the activities of the College, Mr. E. A. Hueni, Chairman of the Education Committee, stated that the maximum number of students who could be admitted had already been enrolled for the term beginning in January. This was an improvement on previous winters, when there had usually been a seasonal decline. Applications were, in fact, already being received in large numbers for the summer term.

It was with regret that the Chairman announced that the Society would shortly lose the services of Mr. Hueni, who had accepted an appointment in Switzerland. He said this was the third occasion within three years that the Society was losing a Chairman of the Education Committee, Mr. Hueni's two predecessors, Mr. Ammann and Mr. Roethlisberger, having both returned to Switzerland. He added amid laughter that it would appear as if the Chairmanship of that Committee formed a stepping stone to higher appointments in Switzerland.

Mr. Hueni, in his farewell address, said he was leaving London, where he had made so many friends, and in particular the congenial atmosphere of Swiss House, with mixed feelings. He concluded by wishing the Society further progress and prosperity.

The meeting was followed by a FILM SHOW. By courtesy of our member, Mr. H. O. Ernst, Manager of the Swiss National Tourist Office, the following coloured Swiss films, which had not previously been seen in London, were shown:— *Springtime in Switzerland*, *Winter in Villars*, *Winter in Saanenmöser*, *Spring in Zermatt*. For many present, it was probably the nearest they could get to winter sports, and the homely scenes and beauty spots depicted were enthusiastically received by the audience. It was a pity that some had to crane their necks or had too close a view from distorted angles in a tightly packed lecture room. Nevertheless, all present enjoyed the excellent films and thanks are due to Mr. Ernst for having provided a most enjoyable evening. It will interest members and friends to learn that from the same source a talking film "100 Years Swiss Constitution" has been promised for our Monthly Meeting on March 8th.
