EUGENE BOREL †

We deeply regret to announce the passing away in Geneva of M. Eugène Borel the eminent Swiss jurist at the age of 93. The deceased was from 1924-1926, President of the City Swiss Club.

Born in 1862 and educated at Strasburg, Berne, and Geneva universities, Borel had been attorney-general at Neuchâtel before he was appointed professor of international law at Geneva University in 1905. In 1921 he was elected president of the first division of the Anglo-German Mixed Arbitral Tribunal and spent several years in London. In 1925 he returned to his university work in Geneva. He retired from his chair in 1929, and three years later was chosen to be president of the arbitration court between Sweden and the United States. He was also a member of the Hague permanent arbitration court, of the International Law Institute, and of the International Law Corporation.
