SWISSAIR'S TRAFFIC RESULTS FOR 1960

In 1960 Swissair carried a total of 1,303,225 sector passengers, or 18 per cent more than in 1959. Capacity produced rose by 23 per cent over 1959 and 18 per cent more capacity was sold.

The transport of passengers and baggage also rose by 18 per cent to 106.8 million ton-kilometres, freight by 19 per cent to 28.2 million and mail by 15 per cent to 6.9 million ton-kilometres.

Of revenue capacity sold, passengers and baggage accounted for 75.3 per cent, freight for 19.8 per cent and mail for 4.9 per cent. The average load factor on the scheduled services was 58.6 per cent, compared with 61.1 per cent in 1959.

In the course of the year Swissair put into service its jet fleet of three Douglas DC-8s and four Caravelles. The jets were introduced without difficulties and have since fully justified the company's expectations.

On the other hand, capacity produced during the year remained 3.5 per cent below the figure budgeted and this had a corresponding effect on revenue. In particular, production was reduced by the late delivery of the DC-8s and difficulties over traffic rights.

At the end of 1960 Swissair's fleet consisted of the following:
