NEWS FROM THE COLONY

SWISS ECONOMIC COUNCIL MEETING

October 16th 1962

Thirty-eight members and guests met at the Dorchester Hotel to hear Mr. Paul Bareau on

"STERLING AS THE EUROPEAN CURRENCY".

Mr. Bareau, a professional economist, had, as the Chairman called to mind, a distinguished record of service as City Editor of the "News Chronicle", as a member of the U.K. Treasury Delegation in Washington 1945/6, a member of a team which, led by Lord Keynes, negotiated the American loan, and again, in the company of Lord Keynes, participating in conferences at the International Bank. Amongst other assignments post-war were lectures in the USA and in Scandinavia under the auspices of the Foreign Office. Mr. Bareau is today Editor of "The Statist".

The lecturer began by saying that the title should perhaps be "Sterling as a European Currency". "I am", he said, "a confirmed pro-marketeer but I can see no COMMON CURRENCY for the next two decades", since this would involve a common budget and common taxation.

What he was conscious of was the PRE-EMINENCE of STERLING as a European currency and the PRE-EMINENCE of LONDON as a financial centre.

This might bear examination even in the event of a future North Atlantic Common Market. Certainly, the Pound was already more widely used in the world than any other European currency. The figure of some £550 millions of short-term Sterling held abroad, either as reserves or as working balances, had no equal, at any rate not on the European scene.

Surveying the reasons that have led to this pre-eminence, Mr. Bareau traced the British achievements of the past: Free Trade, industrial supremacy, massive balance of payments surpluses, the momentum derived from these — "and we are still a substantial exporter of capital" — the compactness of the City institutions, the trust obtaining in them, between them and from them, the British genius for putting people on their honour (he instanced Exchange Control procedure), empiricism, intolerance of dogma and of economists.

Mr. Bareau quoted the memorable statement ascribed to Mr. Montague Norman on Mr. H. Clay's appointment as economic adviser to the Bank of England: "You are not here to tell us what we should do but to explain why it is we have done what we have done."

It was remarkable that in post-war years there had been a complete failure of other currencies to take advantage of the opportunities to fulfil Sterling's role.

Sterling was a currency worthy of confidence. The purchasing power of the Pound was fair, so was the competitiveness of British industry. Exports to Western Europe were on the increase. The budgetary and financial positions were sound. Mr. Paul Chambers' remark about the "inexorable efficiency of the British tax machine" was suggestive, in the lecturer's mind, of a worthy British contribution in the administrative field. Lastly, Britain possessed political maturity.

Mr. Bareau then considered, what he called, the burden of a key currency, the problem of international balances and their relationship with the gold exchange standard, the continuing shortage in the supply of gold and the MAUDLING plan, ending with another famous

quotation: "Faites moi de bonne politique et je vous ferai de bonnes finances."

In the discussion, Mr. D. A. V. Allen, Under-Secretary of the Treasury, gave a few details about the genesis of the Maudling plan. Mr. S. Golt, Under-Secretary of the Board of Trade, followed, as did Mr. F. W. Hardstone, Chief Deputy General Manager, Westminster Bank, who remarked on the change away from the London market of certain types of lending (Argentine Railways). Mr. Hardstone also offered a word of appreciation on behalf of the guests.

The Committee is making strenuous efforts to rent a room in Central London where the young Swiss girls can meet and spend their free time.

The permanent members of the Swiss Catholic community are unable to carry on, as well as they would wish, this valuable work which is growing from year to year and is so very important to the good reputation of our Swiss compatriots in Great Britain, without calling upon the generosity of all their friends.
