As on so many former occasions, we have once again to bid farewell to a member of the Swiss Embassy.

The Federal Council has recently announced the transfer of Consul E. Ribi to Zagreb (Yugoslavia) in the same capacity.

By his departure we are losing a man who has taken, apart from his official duties, a keen interest in the Swiss Colony. His advice, sought in many intricate cases, was always readily given, proving most helpful. Nobody seeking information on any sort of question or problem was ever refused a hearing, and we take this opportunity of thanking him for the services he has rendered both to our country and to the Swiss Colony. Only recently he has worked exceedingly hard in connection with the Charity Concerts at the Institut Français to make these undertakings such a success.

On the social side he was greatly aided by his charming wife, who accompanied him untiringly to a great number of functions. She took a lively interest in the work for the young girls, the Swiss Benevolent Society, the Swiss Church and the "Frauenverein". To her, too, go our thanks for all the services she has so untiringly rendered.

Consul Ribi was born in 1906 at Schaffhausen, where he was educated. After first embarking on a banking career, he entered the Swiss Consular Service in 1927. His first assignment was with the Swiss Consulate at Manchester, then Montreal, San Francisco, and Tokyo, where he spent the war years. He was from September 1946 to July 1957 Vice-Consul and Chief of the Consular Section at the Swiss Legation in Mexico. Mr. Ribi married Miss Margaret Holliger, and has two children, Elisabeth and Peter, aged 21 and 20 respectively.

A hitherto successful career has now entered another new phase, and we have no doubt that his work in the new surroundings will be equally successful and beneficial.

In this departing hour we will not say "Farewell" but "Auf Wiedersehen!"
