JOHN M. FREI †

As we announced previously, we deeply regret the death of Mr. John M. Frei, of 33a Orchard Avenue, Shirley, Croydon, on 14th July. He was born on 7th December 1890, a farmer's son of Watt-Regensdorf (Zurich). Having done his initial military service, he went to Barcelona in 1911, and two years later he came to this country. His first position was with the famous Whisky Distiller's John Walker & Sons Ltd., and next he joined the Standard Supply Agency. Mr. Frei founded his own firm of Boyden & Co Ltd., in 1925, and the second world war brought business to a standstill. He worked in the Special Division of the Swiss Legation, and after the war, he resumed business as Boyden of Croydon, Tile Merchants. The firm became the largest single producer of glazed ceramic tiles in the U.K. He has been taking things a little easier of late, but he still went to business every day and visited customers.

After the first war, he married Miss Grace Grey, and they had two girls and a boy. It is to them that we extend our deep sympathy in their bereavement. It is gratifying to know that his son John who joined the firm in 1948, will continue in his father's business as Chairman of the Company. Mr. Frei lost his wife in 1966, having enjoyed a very happy marriage. One of the highlights of their life together had been a cruise to South Africa in 1958/9.

John Frei took an active part in the Swiss community. He joined the Swiss Mercantile Society in 1919, and thus he would have qualified for the Veterans' distinction next year. He was a member of the General Purposes and House Committee of the S.M.S. In 1950, he joined the City Swiss Club, and he was a loyal supporter of the Swiss Benevolent Society, also of the Swiss Church and many other organisations.

For twenty years, he was a member of the Helvetica Lodge, occupying the chair in 1965, in his 75th year.

A large circle of business friends, neighbours and fellow countrymen mourn his death. He was a cheerful character who was always ready with a joke. He enjoyed his cigar and his *Stumpen* and a game of cards (*Jass*). His great kindness and generosity will long be remembered.
