At the invitation of the municipalities of Montreux and Veytaux, a representative body of foreign residents of different nationalities has given support to the creation of the "CLUB INTERNATIONAL DE MONTREUX", open both to foreign and Swiss residents alike, having as its object to allow the two groups to meet socially and to link the foreign residents of the area with the authorities and the population. A clubroom is placed at the disposal at the Casino of Montreux by the municipalities, and a qualified person will be in permanent attendance for giving information and rendering services. Mr. William B. Sigerist, a Swiss resident of Territet, has been elected President. Congratulations!

At an Extraordinary General Meeting in Basle on 15th of October, it was decided to increase the share capital of the Bank from 300,000,000 to 330,000,000 francs by the issue of 60,000 new bearer shares of Fr.500.—

The new shares will be issued at the price of Fr.1,000.— in the proportion of one new for every ten old and will rank for dividend as from 1st July, 1968.
