“ ENGAGEMENT ”

“ The task which you fulfil has provided you with a *doctor honoris causa*. ” But long before, the refugees had bestowed another title on you: “ Mother of Refugees ”. These are words of high appreciation for the work of the “ Christian Peace Movement ”, expressed by our former Federal Councillor, Monsieur M. Petitpierre, some years ago, on the occasion of the seventieth birthday of its leader: Frau Doktor Gertrud Kurz. Those who came to the Swiss Church during the Week of Reflection got an insight into the work of Mutter Kurz.

The Christian Peace Movement came into being shortly after the first world war because two enemies, a German Mayor and a French Officer got to understand each other better, due to a communion service which they had both attended at the local Protestant Church of Datteln, a German town then held by the French troops. The Lord's Supper which marks the reconciliation between God and man produced reconciliation between the two enemies. These two men in their capacity of Mayor and Officer ended the bloodshed in Datteln and created a movement of reconciliation.

During the second world war, the Peace Movement had to operate from Switzerland where, under Frau Kurz, it became a family of refugees. After the second world war it was largely taken over by young people who had realised that reconciliation with God means “ engagement in the world ”. They are Christians from Western Europe as well as from East Germany. They work in those parts of the world, where there is unrest and hatred: in Jordan as well as in Israel, in the Southern as well as in the Northern part of Vietnam, and in Algeria, Rhodesia and Greece.

Thus the Week of Reflection drew the thoughts to “ God and engagement ”. On 7th May, Mutter Kurz spoke to elderly people about “ problems of getting older ”, the following Wednesday afternoon she addressed the members of the Mothers' Group with a talk on refugees and in the evening the “ Kontakt ” on “ Youth ”; Thursday she was received by the “ Jeunes Romands ”, and on Sunday, 12th May, she preached at St. Mary Woolnoth's to a crowd of mainly young people. At the end of the Week of Reflection Mutter Kurz was given £150, a collection which shows the impression on those who had attended.

It was also announced that arrangements were being made to organise a dinner at a country club at Elstree (Herts.) on a Friday in August, and a Sunday outing to Hever Castle near Westerham (Kent) in autumn — possibly on 6th October. Further details will be given in the “ Forthcoming Events ” columns in the Swiss Observer and by circulars to the Club's members.
