We reprint the following from the "Yorkshire Post" (26th May):

"The weekend is the idea of Calder Civic Trust.

"The streets of the town are to be decorated with bunting, banners and Swiss flags, and shopkeepers are being asked to make displays of Swiss goods, and restaurants to serve Swiss food."

From the "Halifax Courier" (22nd April) comes the following:

"Another feature of the Swiss link is that this year's visit in June to Hard-castle Crags and Hebden Bridge will be the 21st occasion that the Swiss people living in the North of England have held their annual meeting in the district."

Both reprints, of course, refer to the annual "Landsgemeinde" to which we drew readers' attention in our last issue. It is the family outing arranged by the Yorkshire and Manchester Swiss Clubs. This year, it will be held the day after the Federation of Swiss Societies hold their Annual General Meeting in Manchester on 14th June.
