One of our readers, Mr. E. Ruchti, Central Secretary for Education and Training of the Swiss Mercantile Society in Switzerland, took part in a study group meeting at the Further Education Staff Meeting at Blagdon near Bristol from 21st to 23rd June. He read a well-received paper on commercial training in Switzerland. The address was doubly

interesting seeing that the vocational training system known in Switzerland, which enables the apprentice to enjoy combined practical and school training in commerce and trade, is unknown in the U.K.

#### J.P. GALLO †

We announced the death of Mr. J. P. Gallo in our issue of 13th June. The following obituary has been sent to us.

If Switzerland has given many sons to the service of other countries, in varying fields, it is certainly true of the *Hôtellerie*. Jacques Pascal Gallo, who died at San Vittore, Grisons, on 29th April, after an association with London for 53 years, is such an example.

Born in Sta. Maria/Calanca (GR) in 1892, he served an apprenticeship in Milan, Algiers, and at the Sauvage at Meiringen. He then came to London in 1913, and held successive posts at the Savoy, Carlton, Berkeley, Ritz, Café Royal, and the famous Pagani's restaurant until its closure just before the last war. In the 1930s he completed various winter seasons at the Palace and Kulm at St. Moritz. Manager of the Hotel Schweizerhof & Post in Bellinzona just after the war, he returned to the Coq d'Or Restaurant in Piccadilly, where, as Chef Sommelier, he specialised in wines until retirement in 1966.

As a founder member and first Chairman of the "Guild of Sommeliers" of Great Britain (which M. André Simon termed: "the best thing which has happened during the last 15 years in England since the War and its legacy of catastrophic wine duties"), he promoted interest in the history, production and serving of wines.

Among distinguished customers, he could include the four sons of King George V, members of the Royal Houses of Luxembourg, Sweden and Holland, General de Gaulle and the French Government in exile, Sir Anthony Eden and members of the wartime Cabinet, Toscanini, Barbirolli, Charles Laughton, Sir Lawrence Olivier.

Although devoted to the English way of life, Jacques Pascal Gallo was above all a strong patriot, steeped in Swiss history, and returning without fail every year to his native Rhaetian alps, to which he ultimately retired. In the London colony, in younger days, he had been Secretary of the Swiss Gymnastic Society and twice President of the Union Helvetia.

He leaves a wife at San Vittore; a son (Assistant Master at Norwich School) and a daughter, *ballerina* at the Municipal Theatre in Lucerne.
