Dr Schweizer is dead

Dr. Samuel Schweizer, Honorary President of the Swiss Bank Corporation, died suddenly on Sunday, 19th June of a pulmonary embolism. He was buried in Breganzona.

Born on 2nd March, 1903, in Basle, Samuel Schweizer studied law at the universities of Basle and Geneva. After spending a short period with a Geneva law firm, he joined the Swiss Bank Corporation in 1929 as legal adviser at the bank's London office. In 1934, he was attached to the bank's general management and in 1950 was promoted to the rank of manager at its Basle office. He was appointed general manager in 1952 and in 1962 was elected chairman of the board of directors, a post he occupied until his retirement in 1972.

Among the many functions he exercised in public life, Dr. Schweizer was a member of the Swiss National Bank's bank council and served as an expert on the Advisory Committee for National Roadbuilding.

In 1968, he had an honorary doctorate conferred on him by the University of Basle in recognition of his services as Patron of the Basle Antikenmuseum and as an expert in international finance and a firm commitment to the Gold Standard.
