«Les enfants d'abord»

A politically and denominationally neutral movement of providence in favour of the child.



1. Aims

The aims are of a preventive policy on international level, so that Switzerland – in case she becomes a full member of the United Nations – pledges herself to appear at the plenary session of the United Nations as advocate on behalf of threatened children, before the outbreak of war, for unfortunately it is always the defenceless and unprotected children who are the first victims.

2. Unacceptable

That is the refusal to accept the *fait accompli* and to allow mental constraint which comes from past history, to overwhelm one again and again. Such rigid ideas only further the perpetual repetition of history and the awful sufferings: the whole is in disastrous relationship to the fate of humanity, and finally based on the ignorance of the ones and the indifference of the others; or it may possibly be an exercise in alibi to calm one's «good conscience».

The most deplorable and pitiable of all tragedies which shake the world, is surely the children threatened by the horrors of war.

For some time, humanitarian organizations have been trying to lessen the regrettable lot of these children; their good efforts are recognized the world over.

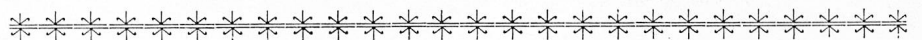
Yet there is a large gap; in the field of prevention, specially in the case of armed conflict. It has been admitted by competent circles that preventive measures within international organizations are rare. It is, therefore, high time that the policy of prevention should be instituted and anchored at the highest international level.

3. The world-wide forum

«Les enfants d'abord» propose that all suffering which affects innumerable innocent children at the moment of threatening danger of war and before the actual outbreak of conflict, should be recalled most specifically in the Forum of UNO.

The call, however, must go out from our country, more exactly: «Switzerland must – in case she becomes a full member of UNO – pledge herself to appear at the plenary session of the United Nations as advocate on behalf of threatened children, before the outbreak of war, for unfortunately it is always the defenceless and unprotected children who are the first victims.»
