UN relations to be **Zurich ASA theme**

"SWITZERLAND and her relations with the United Nations" is the theme of the Assembly of Swiss Abroad to be held in Zurich from August 26 to 28. Questionnaires regarding the main topic have been sent to societies and appeared in the "Review", so that Swiss residents abroad have a chance of expressing their opinions about whether or not Switzerland should join the United Nations Organisation.

At a meeting organised by the Nouvelle Société Helvétique in London, the subject was discussed on May 19. The

Minister at the Swiss Embassy, Monsieur Claudio Caratsch, introduced three of his colleagues who gave short talks on the message of the Federal Council to Parliament, the constitutional position of Switzerland, her neutrality and how a possible accession might affect Switzerland's "good services" in the Red Cross organisation.

A lively discussion under the chairmanship of Mrs Mariann Meier followed, and it became clear that a large number of questions had to be answered for many members of the audience

before they could make up their minds. More information was, in fact, wanted by 36 per cent, 36 per cent voted for Switzerland's entry, 14 per cent against, while another 14 per cent would not wish to vote in the final plebiscite one way or another.



In April the NSH had organised a talk, illustrated by a film, by Monsieur Robert Gaillard on "The International Committee of the Red Cross in Geneva," of which he is a delegate. A discussion followed the talk on this great humanitarian institution.

The New Helvetic Society also took part in the Swiss Cultural Week, from May 20 to 25 both at the Institut Français and the Swiss Embassy.

THE annual dinner of the London Swiss Philatelic Society took place at the Throgmorton Restaurant.

After the enjoyable meal, the president, Mr W. Burren, welcomed those present, especially those who had come a very long way. He gave a special mention to Mr and Mrs Hausermann who had returned from Australia to be present.

After thanking the secretary, Mr R.A.G. Foster, he proposed a toast of the guests.

The reply was given by Mr Orme, one of Mr Foster's accountant colleagues. Since it was not his first dinner with the "London Swiss" he decided to make his speech short and thanked the society for inviting him.

The next item was the tombola in aid of the society's funds which, thanks to generous gifts, produced a handsome result.

Many members who had joined the society since its foundation, people like Mr Thompson, Mr Beken and Mr Streit, were remembered with honour. The official business was completed by the members passing a vote of congratulation to Mr Burren on becoming president of the Swiss Mercantile Society.

Generous refreshments pre-

pared by members of the society and their ladies were then offered, and then followed an interesting display of rare stamps such as French Art stamps (Mr Gay) and the Swiss Evangelist high value stamps. Indian stamps included the well known threevalue Gandhi set (Mr Burren).

A selection from the German collection of the late president, Mr Streit, was submitted by his daughter, as was his collection of Swiss charity stamps. Finally, there was an interesting display of League of Nations items and many others by Mr Smith.

The evening finished with an auction of the remaining few unopened bottles of wine and the president's vote of thanks to all those who had contributed to the success of the evening.
